- Late, unsigned, or incomplete bids will be disqualified,
- Bidders are requested to submit on original bid document clearly marked "original"
- Bidders must ensure that the company status is "In business" with the Company and Intellectual Property Commission (CIPC),
- Bidders are requested to read and take note of the "information to bidder: attached on the bid document,
- Bidders must submit original or certified copies of B-BBEE Status Level Verification or Affidavit together with the bids to substantiate their B-BBEE rating claims,
- A Trust, consortium or Joint Venture must submit a consolidated B-BBEE Status Level Verification,
