- Bids must only be submitted on the bid documentation provided by the Ngwathe Local Municipality official form – (not to be re-typed/re-arranged);
- Persons in the employment of state are not allowed to bid;
- Late, unsigned, or incomplete bids will be disqualified;
- Bidders are requested to submit on original bid document;
- Bidders must ensure that the company status is "in business" with the Company and Intellectual Property Commission (CIPC);
- Bidders must submit original or certified copies of B-BBEE Status Level Verification or Affidavit together with the bids to substantiate their B-BBEE rating claims;
- A Trust, consortium or Joint Venture must submit a consolidated B-BBEE Status Level Verification or Affidavit together with the bids to substantiate their B-BBEE rating claims;
- Bidders must ensure compliance with their tax obligation and submit a tax clearance certificate or a unique personal identification number (PIN) issued by SARS to enable the Bid Committees to view the taxpayers profile and tax status;
- Bidders must submit municipal rates and taxes certificate for not more than 3 months in arrears, (both directors & company).
