

PUBLIC SAFETY AND DISASTER MANAGEMENT

As per an instruction from PSIRA these are the requirements when you appoint an external service provider on security.

- ✓ The business must be registered with the Private Security Industry Regulatory Authority? (A Registration Certificate to this effect must be made available)
- ✓ The business must produce a valid letter of good standing from Psira?
- ✓ The Security business must be registered with COIDA?
- ✓ The business must be registered with UIF?
- ✓ The business must be registered with PSSPF? – if exempted get exemption letter and proof of registration with another fund.
- ✓ The business must be registered with SARS?
- ✓ All of the employees deployed to render a Security Service must be registered with the Authority (Please note that PSIRA documents for security officers should be submitted 5 days after the appointment)

NB: Please note that 05 points in Heilbron and 10 between Parys and Tumahole does not have guard houses; you will be expected to provide your own
